Through our partnerships, the TMDF continues to grow educational, career and outdoor experience opportunities for Veterans while other partnerships maintain a framework for sharing the history of the 10th through writings, photos, film, exhibits and living history events.

I embrace these "Good Works" and the inspiring stories about an organization and individuals dedicated to their roles as stewards of the 10th legacy shared in this publication. Several years ago, Trux Dole, TMDF Chairman, handed down a challenge to all Directors: we need to make the Foundation more relevant. With this challenge and Steve's words, I believe the TMDF does have an opportunity to expanded our leadership and stewardship roles going forward. To this end, I took on my own challenge. Recently I was invited to share my thoughts about the Colorado Outdoor Recreation Economic (CORE) Act legislation

I shared the following with a group of veterans, legislators and advocates: the recognition of the legacy of 10th Mountain Division by virtue of the designation of Camp Hale as a Historic Landscape is the foundational element to the CORE Act. For it is the heritage – the story – that informs our present and future. This designation brings authenticity and relevance to the preservation of the proposed public lands necessary to expand the economic impact of Colorado's outdoor recreation industry. It was a timely opportunity to share how our history informs our present and future, making us more relevant!

The 10th Mountain Division Foundation has enjoyed a longstanding partnership with the 10th Mountain Division Hut Association.

The partnership includes sharing the story of the 10th Mountain Division and their love of the mountains through 10th materials at the huts. The staff and work crews of the Association are unfailing in their assistance with maintenance at the 10th Mountain Division Memorial at the top of Tennessee Pass.

In 2014 a Colorado state statute established the sale of custom license plates honoring the 10th Mountain Division. This further solidified the partnership. Led by then TMDF Chairman Tom Hames, a portion of the revenue is earmarked for the Hut Association. The Association uses the funds to advance their Backcountry Exploration Program.

The program encourages the use of huts by educational nonprofits, promotes a better understanding and appreciation of the natural mountain environment and develops individual self-reliance among hut users. They assist nonprofits financially, and offer guidance in trip planning. Who can participate? Nonprofits with an educational emphasis such as schools,

youth organizations, churches and senior citizen groups have received up to 50% off whole hut rentals during the week.

The most extensive of the Colorado ski hut systems is managed by the 10th Mountain Division Hut Association. A nonprofit corporation, the Hut Association was formed in the early 1980s by several Aspen skiers, including 10th Mountain Division veteran Fritz Benedict.

The first 10th Mountain Division Huts built were the McNamara and Margy's, completed during the summer of 1982.

I then learned the contact for the Foundation was a descendant of a 10th Mountain Division WWII veteran, John M. Garrett



Garrett, Jr. as a post-war Businessman, circa 1953 **Recently I read Keith Garrett's reflections** on his father and his service which he wrote after researching his father's records and his family's participation in a 10th Mountain Division Descendant's "Return to Italy" trip. His writing provided the connection to the Garrett Family's commitment to philanthropy. Keith's journey of discovery began when he was 16 and had read "Remount Blue: The Combat Story Of The 3d Battalion, 86th Mountain Infantry" by David Browers.

This gave Keith the foundation to learn, in his father's words, about his time on the "Big Lake" (Garda) in a DUKW boat and his thoughts on the war: Those were the thoughts of a survivor, friend, soldier, civilian and defender of civilization. "My dad's expressions of having experienced evil on a level of utter disbelief were vivid. As were his motivations, will, and courage as one of the we who flushed them out. This is something I continue to ponder and I hope that the extended generations of our family will do so as well."
